### Experience

She is highly regarded for her experience in handling complex negotiations, lawsuits and domestic and international arbitrations related to civil and commercial matters and has vast experience in disputes related to product liability and alleged consumer law violations. Her practice also includes advising on civil and commercial contracts and transactions, as well as pre-dispute advise. She is highly regarded by her negotiation skills.

She has been recognized by international publications such as "Chambers & Partners" and "Legal 500" for her performance in litigation and arbitration. She has been shortlisted in Euromoney Legal Media Group Rising Star Awards 2019 as "Best rising star litigator in Latin America".

Such project required the Firm to issue a comprehensive report about its local legal system to help people understand and defend their rights to avoid unfair trials and unfair results. ## Work highlights

Actively advises CODERE MEXICO, a renowned multinational in the private gaming sector, and has represented CODERE in an extremely challenging multi-million arbitration brought by a minority shareholder before the International Chamber of Commerce (ICC).

Under her leadership a very significant suit was dismissed by the Supreme Court of Justice against Quest Capital Advisers Agente de Valores (a stock broker) and Andorra Banc Agricol Reig S.A., brought by an investor claiming millions of dollars' compensation driven from the alleged wrongful sale of Argentinean Defaulted Bonds.

Successfully advised Tanosis S.A. in several extrajudicial and judicial multi-million claims brought by several alleged timeshare resort holder rights of the former "Las Dunas Hotel Club" located in Punta del Este, who alleged the deprivation of their rights to use the property.

Actively leads the team that advises Petroleum Geo- Services In and GX Technology Corporation, international companies that provide seismic services, in a multimillion claim brought by thirty fishery companies, against the National Administration of Fuels, Alcohol and Portland ("ANCAP") and the Uruguayan State, claiming damages allegedly produced by their negligence as per admitting the development of seismic prospecting activity in Uruguay without proper due diligence, control and mitigation measures.
